

Bonds Zippy Swap Meet Event – the Rules

Event dates and location:

Sunday 9 July 2023

Pre-registration

Each attendee aged 18+ must register for the event. Registered attendees may bring along dependants aged under 18 years of age and do not need to register those dependants. All dependants must be accompanied by a registered ticket holder and must be under the direct supervision of, and are the responsibility of, that ticket holder at all times while attending the event.

Registration opens 3pm AEST 23 June, 2023. Registration will close 10am Friday July 7 (unless tickets are exhausted prior).

To register, visit [Eventbrite](#). Eight arrival slots are available from, 11:00am to 2:45pm. A maximum of 40 ticket holders can register for each session. You may only register for one of the eight available arrival slots. Tickets are free and limited to one ticket per person. To register, you must:

- complete the registration form;
- agree to abide by these the event terms and conditions, both personally and on behalf of any accompanying dependant; and
- opt in to receive emails from Bonds.

If tickets are still available for your session of choice, you will be issued with an event ticket. That ticket will be sent to you by email, using the email address provided in your registration form.

Tickets are non-transferable. If you are unable to attend the event you can deregister from the event by updating your attendance on the Eventbrite website via the 'view and manage your order online' button on your registration ticket email.

Attendance at the Event

Each attendee will need to arrive at the appropriate session within 10 minutes of the arrival timeslot. Attendees should not attend the event if they feel unwell, have COVID or have been in contact with a COVID case in the 7 days prior to the event.

Attendees must present their ticket in either electronic or hard copy form to the staff at the entry. ID may be requested. Photos of the ticket will not be accepted. Attendees must also present to staff their Bonds Zip Wondersuits to be forfeited and swapped for Bonds Zip Wondersuits provided by others and available at the event. A minimum of one Bonds branded Zip Wondersuit of acceptable condition must be provided to gain entry.

Upon verification of the condition of the Bonds Zip Wondersuits, attendees will be provided with Bonds Bucks as follows:

- a. 1 Bonds Buck for pre-loved Zippys without tags.
- b. 2 Bonds Bucks for pre-loved Zippys with tags.

Once the Bonds Bucks are issued to an attendee, the attendee will be admitted to the event and may proceed to the shopping area.

Once the Bonds Bucks are issued to an attendee, attendees cannot reclaim their Zippys, other than by exchanging their Bonds Bucks for the Zippy if it remains available in the “shopping section” of the event.

Bonds does not retain any information regarding which Zippy was forfeited by which attendee and is not able to share any attendee information with other attendees. Bonds has no responsibility for any Zippy's selected by an attendee at the event (unless otherwise required by law). Attendees recognise that the Zippys they select are second hand and take possession of these garments at their own risk. Attendees are responsible for carefully inspecting any Zippy they wish to take from the event to ensure it meets their needs. If attendees identify a fault in a Zippy at the event that rendered it unsuitable for use in the event, they should bring that issue to the attention of a staff member immediately and at the event. Returns of items will not be accepted by Bonds after the event.

All attendees consent to their image, and that of their accompanying dependants, being captured via photography and videography at the event. That imagery may subsequently be used by Bonds or its agency responsible for this event, ARC, in promoting the event, their brands and their collaboration through any medium and in any location without further permission or payment to any attendee or dependant. Bonds and ARC will ensure that any such use is reputable.

Entrants and their accompanying persons attend the Bonds Zippy Swap Meet event at their own risk. All participants agree to behave in a polite and orderly manner. Unacceptable, illegal, unsocial or unsafe behaviour will lead to eviction. No bikes/skateboards/scooters, smoking or vaping, alcohol, or animals other than assistance animals are permitted in the venue. Bonds reserves the right to check bags, prams and strollers on entry and exit.

Acceptable Quality

Zippys will be accepted if they meet the below parameters.

DO'S

1. Must be a Bonds Zip Wondersuit (can be classic or romper shape).
2. Must be in a condition you'd be comfortable giving to a friend or loved one.
3. Must be freshly washed.
4. Must have the sizing label.
5. Two-way zip must be functional.
6. Cosy cuff mitts and feet intact (available from size 000 to 0).
7. All stitching intact and pip tag and other labels securely attached.

DON'TS.

1. No holes.
2. No irreversible stains.
3. No customisations to the garment.
4. No sewn-in labels or embroidery.

General

Bonds will not be responsible or liable if for any reason beyond its reasonable control any element of the event is not provided. Bonds will not be responsible for any changes in times or dates, or cancellations or rescheduling of the event that may prevent the ticket holder from attending the event. If the event is cancelled, varied or rescheduled for any reason, then at Bonds' discretion, the ticket holder will forfeit all rights to attend the relevant event and no cash or alternative tickets will be awarded in lieu.
