

GIFT TERMS AND CONDITIONS FOR AS WORN BY US – BONDS STORES

1. Information on eligibility and gifts form part of these conditions. By participating in any of the promotions, customers agree to be bound by these conditions. Entries must comply with these conditions to be valid.
